# 特許仲裁學會東亞分會台灣支會 特許仲裁學會 國際仲裁課程

CIArb Accelerated Route to Membership – International Arbitration (ARM Course) in Hsinchu, Taiwan

近年來,國際仲裁相關議題持續受到各界矚目。對台灣涉外案件實務人士而言,不得不重視及了解應如何處理國際仲裁事件。特許仲裁學會(Chartered Institute of Arbitrators http://www.ciarb.org/about)自 1915 起提供國際爭端解決之相關教育訓練,至今已有 102 年歷史。目前特許仲裁學會擁有大約15,000 名會員,分布於世界 133 國家,並設有 38 個分會。本次仲裁課程將提供對國際仲裁事件處理之教育訓練,涉及之議題包括:國際仲裁之基礎原則、案件處理之注意事項等。課程適合執業律師、仲裁人、政府相關部門人員、公司法務參加。本次課程將全程以英文進行,教材亦均為英文。學員們在課程開始兩週前將收到教材電子檔案,應於課前積極自習並完成課前報告。課程共分兩階段,第一階段為小組討論及測驗(全程評分),第二階段則為筆試,通過者可取得特許仲裁學會之會員資格(MCIArb)。

# ARM Course 11-10 March 2018

The Taiwan Chapter of CIArb East Asia Branch and CAA (Chinese Arbitration Association, Taipei) are now receiving registrations for ARM (Accelerated Route to Membership), an intensive fast-track course conducted in English and designed for qualified professionals wishing to obtain the Institute's Membership designation "MCIArb". It is also an essential step for anyone aiming for Fellowship ("FCIArb"). Non-members of CIArb are welcome to register for the course, however preference will be given to CIArb Associates if space becomes limited.

This is an **assessment course** and not a teaching course. Learning will be based on pre-course self-study, reinforced by workshops conducted in small groups where all candidates are expected to participate actively in discussions.

- Two weeks before course commencement (23 February 2018): Candidates will receive course materials together with a **pre-course assignment** to be submitted before day one of the course begins.
- Saturday, 10 March 2018 (09:00–18:00): Day one of the course consists of assessment workshops during which candidates will be assessed on knowledge, judgment and presentation.
- Sunday, 11 March 2018 (09:00–13:00): Day two of the course is a closed book written examination.

# **Anthony Houghton S.C.**

Tony first qualified as a Chartered Quantity Surveyor in the United Kingdom, and practiced there and in Hong Kong. He later studied law, and was called to the Bar in England and Wales in 1988, and in Hong Kong in 1989. He has practiced as a barrister since then, in general civil and commercial litigation, but with a particular emphasis on construction and engineering work, especially arbitration.

#### Dr. Helena H. C. Chen

Helena is qualified in Taiwan, Mainland China and New York State. He was the former chair of CIArb's Taipei Chapter and is an adjunct professor of Soochow University law school.
